PROPOSED AMENDMENTS TO THE BYLAWS OF CYPRESS VILLAGE PROPERTY OWNERS ASSOCIATION, INC.

- 1. Section 3.2 of the Bylaws of Cypress Village Property Owners Association Inc. is amended to read as follows:
 - 3.2 <u>Time Place and Frequency of Meetings.</u>
 The annual members' meeting shall be held within Citrus County at a location designated by the Board of Directors at 7:00 P.M., on the <u>third or fourth Wednesday week in March of each year</u>, for the purpose of electing directors and transacting any other business authorized to be transacted by the members provided, however, that if that day is a legal holiday, the meeting shall be held at the same hour on the next day that is not a legal holiday.
- 2. Section 6.4 of the Bylaws of Cypress Village Property Owner's Association Inc. is amended to read as follows:
 - 6.4 <u>Assessments Determined/Assessment Payment</u>
 Annual assessments will be determined for each fiscal year on or before the thirty-first (31st) day of March. Invoices for annual assessments will be issued to Owners on or before April 7th of each year. Annual assessments must be paid on one (1) installment not later than May \mathcal{F}^{th} -30th of each year. Payments not received by May \mathcal{F}^{th} are past due.
- 3. Section 6.5 of the Bylaws of Cypress Village Property Owners Association Inc. is amended to read as follows:
 - 6.5 Past Due Assessment Payments

 If an annual assessment is not received by May 7th 30th, a late payment penalty of \$25.00 will be levied, along with interest from the due date at the rate of 18% per annum. Interest and penalty will continue to accrue until paid in full.
